Be it ordained by the People of the City and County of San Francisco: Section 1. The Board of Supervisors hereby finds that the Clay Street Center located at 940 Powell and 965 Clay Streets, being lote 18 and 24 in Assessor's Block 224, has a special character and special sesthetic, architectural and historic interest and value, and that its designation as a Landmark will be in furtherance of and in conformance with the purposes of Article 10 of the City Plonning Code and the standards set forth therein.

(a) Designation. Pursuant to Section 1004 of the City Planning Code, Chapter II, Port II of the San Francisco Municipal Code, the Clay Street Center at 940 Powell and 965 Clay Streets is hereby designated as a Landmark, this designation having been duly approved by Resolution No. 8751 of the City Planning Commission, which Resolution is on file with the Clerk of the Board of Supervisors under File No. 98-80-15

(b) Required Data. The descriptions of the location and boundaries of the Landmark site; of the characteristics of the Landmark which justify its designation; and of the particular features that should be preserved; as included in the said Resolution, are hereby incorporated herein and made a part hereof se though fully set forth.

WHEREAS, A proposal to designate the Clay Street Center at 940 Powell Street and 965 Clay Street as a Landmark pursuant to the provisions of Article 10 of the City Planning Code was initiated by the Landmarks Preservation Advisory Board on April 16, 1980, and said Advisory Board, after due consideration, has recommended approval of this proposal; and

WHEREAS, The City Planning Commission, after due notice given, held a public hearing on October 16, 1980 to consider the proposed designation and the report of said Advisory Board; and

WHEREAS, The Commission believes that the proposed Landmark has a special character and special historical, architectural and aesthetic interest and value; and that the proposed designation would be in furtherance of and in conformance with the purposes and standards of the said Article 10;

THEREFORE BE IT RESOLVED, First, the proposal to designate the aforementioned structure, the Clay Street Center at 940 Powell Street and 965 Clay Street as a Landmark pursuant to Article 10 of the City Planning Code is hereby APPROVED, the precise location and boundaries of the Landmark site being those of Lots 8, 18 and 24 in Assessor's Block 224;

Second, That the special character and special historical, architectural and aesthetic interest and value of the said Landmark justifying its designation are set forth in the Landmarks Preservation Advisory Board Resolution No. 194 as adopted on April 16, 1980 which Resolution is incorporated herein and made a part thereof as thoughfully set forth;

Third, That the said Landmark should be preserved generally in all of its particular exterior features as existing on the date hereof and as described and depicted in the photographs, case report and other material on file in the Department of City Planning Docket LMSO.7:

AND BE IT FURTHER RESOLVED, That the Commission hereby directs its Secretary to transmit the proposal for designation, with a copy of this Resolution to the Board of Supervisors for appropriate action.



Julia Morgan was a woman pioneer architect with many firsts. She was the first woman to be graduated in engineering from the University of California, Berkeley; the first woman to study at the Ecole des Beaux Arts; and the first woman architect licensed in California. The YWCA and the Women's Residence Club reflected the era when women sought equal rights entering the world of men, while the Chinese YWCA reflected the process in the socialization of the Chinese into American traditions.

Julia Morgan was the most important woman architect in America. The Clay Street Center and the Residence Club are examples of her high quality work.


